**Agreement on support to: Danmarks Bløderforening - DBF**

Pfizer wishes to provide support to Annual Meeting 2025 and has therefore entered into this Agreement with Danmarks Bløderforening (hereafter referred to as the Recipient).

The purpose of this agreement shall be support DBF to organise the annual meeting.

The agreement shall be in effect from April 26, 2025 to April 27, 2025.

Pfizer's financial commitment in relation to this Agreement shall be DKK 47.680,00 excl. VAT.

Pfizer will not provide any non-financial support.

**Roles of the parties in the project**

Pfizer undertakes to provide support as per this Agreement.

The Recipient undertakes to conduct the activity in a professional manner and in compliance with the Promotion Code of the Ethical Committee for the Pharmaceutical Industry (ENLI).

The support Pfizer will provide is given under the condition that it is used to cover expenses in connection with academic and scientific activities including appropriate amount of food and beverages.

It may not be used to sponsor or organize activities of a solely social or cultural character or any other non-academic activities.

Any promotional activity/display must be separated from all academic and scientific activities and in addition it must be separated from the general public.

Please be aware that according to ENLI rules no gifts must be provided to healthcare professionals, unless they fall into a category of items that are otherwise permitted under the ENLI Promotion Code. This prohibition applies for all activities sponsored or co-sponsored by a pharmaceutical company.

If the support provided by Pfizer is fully or partly spent on an activity performed by a healthcare professional that is subject to the law regarding healthcare professionals' affiliation with pharmaceutical companies, then you must ensure that:

- The healthcare professional is informed to report affiliation with Pfizer to the Danish Medicines Agency, and
- Pfizer is informed of the healthcare professional's full name, email address, workplace, authorization ID, time period of the activity (date(s)) and the amount of payment received by the healthcare professional.

Note:

If the activity does NOT fall under the following categories: Teaching/lecturing, Professional information without advertising purposes, and Research, then the healthcare professional must request and await permission from the Danish Medicines Agency before commencing the activity.

### **Report of activity to ENLI**

The sponsorship is reported to ENLI, prior to the activity and by Pfizer's opinion it is in compliance with all applicable rules although the arrangement has not been pre-approved by ENLI.

### **Documentation**

Upon Pfizer's request, the Recipient shall provide documentation that the support is spent in accordance with the Agreement and that the combined support does not exceed the actual expenses. Any surplus shall be refunded to Pfizer.

### **Data Privacy**

By signing this Agreement the Recipient agrees that Pfizer archives information about the Recipient and persons employed with the Recipient, who are or have been involved in this agreement. The Recipient carries the responsibility, that the persons who are involved in the agreement are informed and accept the processing and transfer of personal data., including name, contact details, and CVR-no in a global electronic system for processing of personal data. The electronic data processing system is accessible for a number of companies within the Pfizer group. The personal data can be transferred by Pfizer to other companies within the Pfizer group, to business partners as well as relevant governmental authorities, when this is necessary. Such recipients can be situated in countries outside the EC, e.g. the United States (so-called third-countries). For transfers from the EEA to countries not considered adequate by the European Commission, we have put in place adequate measures, such as by ensuring that the receiver is bound by EU Standard Contractual Clauses, to protect your personal data. By signing this Agreement the Recipient agrees that Pfizer may transfer such personal data to third countries in order to fulfil this Agreement and for the purpose of precise identification of Pfizer's business partners.

The Recipient is entitled to contact Pfizer, if the Recipient wishes to access the processed personal information about the Recipient. The Recipient is further entitled to have the relevant information changed or deleted. This applies for all persons mentioned in this section.

By signing this Agreement the Recipient confirms to have read and understood Pfizer's Representations and Warranties pursuant to Appendix A ("Representations and Warranties") and that the support is spent in accordance with the above mentioned terms and conditions.

We kindly ask you to return the signed agreement to Pfizer.

## **Appendix A - Representations and Warranties**

- 1.1 The financial support from Pfizer will not cause your entity and, to your knowledge, any individuals affiliated with your entity or this support, to do anything that would result in Pfizer improperly obtaining or retaining business or gaining any improper business advantage;
