1. Background

The purpose of this agreement is to contribute to the development of the association and to mutual exchange of experience with the Danish Society for Bleeding in Denmark, as well as to support the association's activities in Denmark.

2. Collaboration projects

Patient material gene therapy

Bløderforeningen will develop patient material for Gene therapy together with health care personell and CSL Behring will support this material with 25.000 DKK. The unrestricted financial support from CSL Behring will be mentioned on the material.

Annual membership meeting April 26-27th 2025

CSL Behring will sponsor Bløderforeningen's annual membership meeting April 26-27th 2025 in Roskilde with 20.000 DKK. CSL Behring's logotype and company name will be presented in the meeting material and CSL Behring will be mentioned as supporter of the meeting in social medias or in newsletters. CSL Behring will participate to the meeting with one representative and will be able to expose patient materials.

3. Finances

4. Transparency

- 4.1 Both Parties consent to the contents of this Agreement being shared with a third party.
- 4.2 Both parties consent to this agreement or a summary thereof being published on the company website and reported to ENLI in accordance with § 3 of the Patient Organizations Code regulated by the Ethical Committee for the Pharmaceutical Industry, ENLI.
- 4.3 CSL Behring AB reports collaboration projects and support for the patient organization once a year to ENLI

5. Consultation, evaluation

- 5.1 Danmarks Bløderforening has appointed Karen Binger Holm as their contact person in matters concerning this Agreement.

5.2 CSL Behring AB has appointed Tove Andersson as their contact person in matters concerning this Agreement.

5.3 After completion of the project, the Parties shall jointly evaluate the projects in p.2 and their collaboration in relation to these projects.

6. Agreement period and early termination

6.1 This Agreement is valid from date of last signature until 31/12/2025.

6.2 If either party fails to fulfil their obligations pursuant to this Agreement and adjustments have not been made within thirty (30) days of the party being requested in writing to do so, the other party will be entitled to terminate the Agreement immediately.

7. Ethical rules and law

7.1 Ethical rules and national law apply to this agreement. Danmarks Bløderforening warrants that it will only use the funds received in accordance with national law and the Pharmaceutical Industry's Code of Ethics.

7.2 Danmarks Bløderforening may not refer to or make any representation relating to CSL Behring or its products or the co-operation under this agreement without CSL Behring's prior written approval. Danmarks Bløderforening shall submit all proposed materials mentioning CSL Behring, or referring to CSL Behring's products, or the co-operation under this agreement, to CSL Behring for written approval prior to publication or use.

8. Disputes

If a dispute should arise in conjunction with this Agreement, the Parties shall primarily attempt to resolve it through negotiation. In the event that the Parties are unable to reach an accord within thirty (30) days of the initial request for negotiation, the dispute shall be resolved in a Swedish Court.

9. E-signature

The Agreement may be executed by means of wet ink signatures or by using electronic signatures. If the Agreement is signed using electronic signatures, in making proof of this Agreement, an electronic copy of the Agreement will suffice. The Parties undertake not to dispute the validity of the Agreement based on the signatures being electronic.






