Support of subject to the following terms and conditions:

1. Sobi's Support

- a) Sobi's Support will be used solely in compliance with all applicable laws, regulations and industry code requirements ("**Applicable Law**").
- b) All travel and accommodation shall comply with:
 - a. applicable ethical codes for healthcare professionals, and
 - b. PO's travel policy, and
 - c.
 - i. Sobi's travel principles: the ground transportation shall be done directly with the ground transportation company by the PO.
 - ii. Reimbursement of out-of-pocket costs (expenses) are subject to provision of original receipts. Sobi may only reimburse business related expenses for a contracted service.
 - iii. Travel and accommodation should if possible be booked 14 days prior to departure or more in advance.
- iv. Sobi will not reimburse expenses incurred by a spouse or other individual accompanying a traveller unless medically necessary. This requires Sobi's prior approval.

If you believe that the Support is in any way intended as, or will serve as, an inducement you will immediately notify Sobi and refrain from attending the Scientific Event.
